


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings




Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings




Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings




Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings


Figure 1609C Ultimate Design Wind Speeds Risk Category I Buildings
